Due to the current situation arising from the spread of COVID-19, Chinese government has temporarily closed the Chinese Visa Application Service Centers and suspended the entry into China by foreign nationals holding visas or residence permits until further notice. Nowadays Chinese embassies have published some updated details of visa applications on the official websites in certain countries about relaxing the restrictions of visa application. Therefore, we suggest you contact your local Chinese embassies first when you plan to apply a Chinese visa, and to recognize if you can make the application along with what documents required. Please notice that the visa application policy may change along with the epidemic situation, and all the information and policies are subjected to the updates which released by the local Chinese embassies when you applying for a visa at that time. All the person travelling from overseas to Shanghai must be subject to 14-day quarantine for medical observation.
